be distributed derive, the Church Council shall, after paying or making provision for the payment of the corporation's liabilities and obligations, distribute all of the assets of the corporation (a) for the purposes of the corporation in such manner as the Church Council shall determine, or to one or more organizations organized, operated exclusively, and exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code, as the Church Council shall determine, so long as its charitable purposes and mission are consistent with those of the corporation, (b) for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (c) to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of in the manner described in the preceding sentence shall be disposed of by the Superior Court or Probate Court of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. No Council, Board, or Committee Member, Officer, employee, or person connected with the corporation shall be entitled to share in the distribution of any of the corporation's assets or property upon its dissolution.
